

# Online Safety: Staff Briefing

Summer 2026

This is a termly staff briefing produced by Knowsley CLCS, it is designed to update school practitioners with some of the latest research and resources to support the delivery of online safety in schools.

## **New Guidance: Protecting School Images from AI Manipulation and Abuse**

The UK Online Harms Early Warning Working Group have published guidance sharing best practice and considerations for education settings and organisations working with children and young people on the use of photos and videos across their online platforms, to address the risk of AI image manipulation. Recent incidents have demonstrated how publicly available photographs can be copied and manipulated using AI tools, including the creation of harmful or sexualised content, which may then be used for blackmail or abuse.

Schools are encouraged to consider the following actions:

- Review current use of pupil images across websites, social media and publications
- Avoid using clearly identifiable, face-on photographs where possible
- Avoid pairing pupil names with photographs
- Consider using images taken from a distance, over the shoulder, or with faces blurred
- Remove metadata (such as EXIF location data) before uploading images
- Use lower-resolution images and review platform privacy settings
- Ensure consent, retention and image-use policies remain up to date
- Include image security and AI awareness within safeguarding and staff training

The guidance also includes practical checklists and advice on responding to incidents involving manipulated or misused images.
